Record of Mission (As of August, 2016)

#### 1. Direct Escort

- (1) Number of direct escort operations: 6 times (739th 744th)

  (The 698th 703th escort operation under Japan's Anti-Piracy Measures Law)
- (2) Number of escorted vessels: 8 vessels (AT of 3,717 escorted vessels since the start of operations under Japan's Anti-Piracy Measures Law)

- Foreign ships other than above: 7 (AT: 3,033)

#### 3. Supplement

The facts regarding the activity of Japan Self-Defense Forces which are described as response to one of the attempted attacks in the IMB first-half of 2016 year report (released at the end of July) is as follows:

— On May 16th, 2016, after having received an emergency signal from a Panama-flagged commercial vessel indicating that it was being chased by multiple skiffs, the destroyer Yudachi, which was in duty of zone defense in the Gulf of Aden, immediately dispatched a ship-borne helicopter to the site.

When the ship-borne helicopter arrived on site, nothing suspicious was observed on the sea around the commercial vessel, and the after having notified the vessel that nothing suspicious skiffs were confirmed, helicopter terminated its activity.

(That is the reason why Joint Staff didn't include this case in the press release as a response of SDF.)
